In Australia, Goodman offers paid maternity leave of up to 14 weeks for primary caregivers, depending on eligibility. Subject to 12 months continuous service with Goodman, a permanent employee will be entitled to be paid for 14 weeks at their normal salary (pro rata for part time employees). This payment can be paid at half pay for 28 weeks. Goodman also continues contributions to the employee's superannuation funds for the period of their parental leave absence. Recent policy changes now mean that an employee is not required to complete another 12 months' service before taking any further periods of paid maternity leave.

Goodman has refined its Diversity Strategy across the business to improve the opportunities for inclusion for all employees and provide equality of opportunity and reward. One of these aims is to increase the representation of females at senior levels. In line with this, the Diversity Committee is being reset to share knowledge and ensure the commitment of the strategy is supported throughout the business. A key action item of the diversity strategy was to review recruitment processes to ensure consistency with recruitment activities and a balanced intake process. This included the communication of the Diversity Strategy to the panel of recruiters to educate them of our stance of diversity along with a requirement that short lists comprise at least

50% female candidates. Also, the introduction of blind CVs is also being rolled out across the business units to anonymise candidates to further combat any unconscious bias.

In the reporting period, Goodman made some key updates to the Parental Leave Policy. For primary carers, Goodman increased the paid parental leave to 14 weeks. Subject to 12 months' continuous service with Goodman a permanent employee will be entitled to be paid for 14 weeks at their normal salary (pro-rated for part-time employees). This can also be paid at half pay for 28 weeks. The payment structure moved to paying the employee the paid parental leave in equal instalments, as opposed to a lump sum payment made pre and post parental leave as captured in the previous reporting period.

In addition to this, another new initiative is that Goodman now continues to make employer contributions to employee superannuation funds during parental leave. This is in response to the issue highlighted in the media that a significant gap in retirement funding is emerging between males and females, which partly can be attributed to females tending to have more prolonged periods out of the workforce (for family breaks) and the associated suspension of superannuation contributions during those times.

Goodman continues to support flexible working and flexible work arrangements have become more common during the current reporting period. The policy is endorsed at the leadership level and it is promoted throughout the business, based on the changing needs and expectations of our workforce. Managers have been educated on the various flexible work arrangements, with both formal and informal arrangements in place. The policy is further supported by the Activity Based Working (ABW) initiative that is in place at Goodman. This ABW initiative allows for more flexibility and accessibly working arrangements, including access to various Goodman satellite offices in addition to the main office locations. The ABW initiative is particularly of value to parents returning to the work place following parental leave, but has also proven to be important to those employees with personal commitments outside of work.

The Talent Management initiative is continuing throughout the Goodman business to further ensure internal promotions are based on merit. The process will identifies and addresses individuals development needs, so training and coaching can be tailored to the individual.

The Goodman business continues to conduct workshops throughout the various teams for the Goodman Role Framework (GRF). The identification of role levels will provide greater transparency in the business for career progression. The Goodman business is committing significant resources to management and leadership for the current team and future years. One outcome of this is to drive improved career development opportunities for female employees, through manager's better identifying possible roles and coaching junior employees to achieve their career objectives. Two Leadership programmes are being facilitated across the business: Leadership Roundtable for the CEO-3 levels and Management Essentials for CEO-4.

Further to the above, general training for all employees continues across the organisation, including organisational skills and presentation skills training.

Goodman continues to have representation in an Industrial Property related initiative, Women in Industrial (WiN), involving a number of property related businesses. The WiN Committee is chaired by a manager from the Goodman Property Services team. The Committee is raising the profile of the industrial sector with females in the property industry.

A new programme Innovate+ has been launched in the Australian business, designed to encourage and support innovation and creativity across the business. The programme was developed to encourage employees to think creatively and without borders. An Innovate+ Committee has been established to provide support and to consider the innovative ideas raised by employees. The Committee is chaired by a Manager from the Goodman Legal team.

The Goodman online induction module remains in place and is communicated to all new starters to complete in the first two weeks of employment at Goodman. The main objective of this module is to ensure new employees have a consistent view on Goodman in particular, employment policies. The module is also designed to bring new employees up to speed faster on critical items so that a smooth transition to the business occurs. Under our wellbeing programme, the (good) life, Goodman has an ongoing programme titled In Focus. This programme is a series of workshops designed for employees to find out more about key business units and/or processes within Goodman. This is an opportunity to share knowledge and information across our current employees with an emphasis on upskilling the development of our employees.

Within the reporting period, Goodman launched a new internal behavioural values campaign named "Project Greatman". The Greatman Award programme has been launched as a global employee award programme designed to reward employees across the business who "live" the Group's Values. Those who demonstrate outstanding behaviour which makes a meaningful difference will be recognised via this scheme.

In addition, during the reporting period the Group has also sponsored The University of Sydney's Graduate Real Estate Competition for the coming two years to provide potential recruitment opportunities for high quality graduates from various real estate related disciplines. One stipulation of the Group's involvement in the sponsorship was that the competition has significant female representation so that future talent pipelines were created.
