Project Progress To Date - OWE



- Earthworks to 2B Pad all but completed.
- Precinct 1 Earthworks 60% completed.
- Precinct 2 Earthworks 75% completed.
- Precinct 3 Earthworks 90% completed.

- Precinct 4 Earthworks 5% completed.
- Western Bund Earthworks 100% completed.
- Sewer Works 20% completed.
- Retaining Walls commenced.



May/June Project Program – OWE

- Complete 2B Pad for Qanstruct.
- Complete bio basin 2/3.
- Continue with earthworks to all Precincts.
- Trim pads as lots are completed.
- Continue with sewer works.

- Continue with retaining wall works.
- Commence stormwater works.
- Finalise new entry to site from Construction Access Road.





Project Progress To Date - WNSLR

North:

- Bulk earthworks Stormwater and services installation across Lockwood Road
- Power outage electrical works along Lockwood Road

Bridge:

- Pipeline protection measures and bulk earthworks of both batters
- Access consent approvals from WaterNSW received allowing bridge piling to commence

South:

- Bulk earthworks removal and import
- Trunk stormwater main installation
- Construction Access Road and driveway connection at Bakers Lane



May/June Project Program – WNSLR

North:

- Complete stormwater and services installation
- Commence pavement construction
- Commence Lenore Drive intersection works
- Commence retaining wall construction

Bridge:

- Install temporary crossing of Ropes Creek
- Construct bridge piles
- Commence bridge column construction

South:

- Complete stormwater installation
- Complete bio-basin construction
- Complete pavement subgrade construction



Consultation and Community Interactions

- Online consultation meeting undertaken with Emmaus College, Trinity Primary and Mamre Anglican Schools to confirm traffic arrangements associated with the Stage 2 development and specifically to advise that Bakers Lane will not be utilised during peak school periods with the use of Abbots Road/Aldington Road during these periods
- Goodman will be undertaking some minor road upgrade works to Aldington Road & Abbotts Road prior to the use of these roads. These will include additional signage, line-marking and road widenings.
- Enquiries received from member of community regarding dust and whether there were any additional measures that could be employed to supress. Goodman and SLR are continuing to consult with the community member and have presented a number of measures that could be implemented to address the issue raised.
